CIRCULAR

Subject: Relocation policy for the contractual manpower working under NRHM.

The State Government has formulated the relocation policy for the contractual manpower working under NRHM. The details of policy are as under.

1. Application of the contractual manpower's for the relocation shall be considered in following grounds:
 - I. Mutual requests for relocation may be considered.
 - II. Applications of professionals who's Spouse are also working in Govt, Govt. undertaking and NRHM may be considered if vacancy exist in that particular place.
 - III. Applications of Physically handicapped, Widows , divorcees and unmarried female, may be considered if vacancy exist in particular place.
 - IV. Application of ANM's/GNM's/ASHA supervisors and other similarly low paid manpower's may be considered for his/her relocation at their home districts.
2. Request of relocation may be considered only after taking in accounts without disturbing existing priority norms and existing strengths of the respective districts.
3. Request of relocation may be considered only once during the contractual tenure only on the valid grounds and, it should not be treated as a right of the contractual staff.
4. Contractual employee has to sign a fresh contract at their new assigned place and old contract will deemed to be cancelled. No TA/DA will be admissible for their relocations.
5. Following system to be adopted for considering the application for relocations at different levels:
 - A. **Within the Districts relocations:**

District Health Society will consider the applications for the matter related to within district level relocations and take final decision according to the above guidelines without disturbing existing strengths of a particular block.
 - B. **Inter Districts relocations**
 - (i) **All contractual staff except ANM/GNM:**

Applications may be submitted to P.D./M.D.NRHM with proper reasons in the light of above policy. Relocation order will be issued after taking prior approval of the Government.

Applications may be submitted to Additional Director (Non Gazzeted) with proper reasons in the light of above policy. Relocation order will be issued after taking prior approval of the Government.
